Implement in pieces of importance. What is needed first.

Need to be mobile, in the shortest amount of time Look at Illinois model to move resources quickly. LTRT's which are heavy rescue locally are fastest follow by the Type IV teams which can roll within 2 hours, etc. Reimbursement issue as well as licensure protection issue.

Training for teams including full scale exercise, position specific, storage and maintenance, administrative can be delayed.

Scott Chappell has been attempting for legislative funding for exercises.

CERFP – Operation Integration VIII – ANG has funding but no funding from state. Two months out but don't have funding for Palm Beach County to be prime agency. August 30<sup>th</sup> Sept. 1<sup>st</sup>. Includes a maritime mission at port in Palm Beach County.

New Business – EMAP – Guided SME's to certification for US&R. 3<sup>rd</sup> party offering certification validation FL 3 and 5 going through certification process. Discussion on if state needs the 3<sup>rd</sup> party validation for national standard.

TF 1 – Brandon Webb Program Manager – USAID and OFTA sent personnel to Joint Humanitarian Ops Course. Patriot exercises with USAF – participated in 5 day exercise. Hosted K9 fundamental skills assessment. Hosted FEMA US&R meetings. Conducted no notice events. Conducting cooperative drill with FIU and it's disaster management Master's program
