DHS funding report

\$3.2 million in funds for 2016. 2016 contracts are out, 2015 contracts are extended.

Get equipment purchased ASAP.

Budget fight within state for funding

FASAR Work Group report

LTRT – meeting later this afternoon. Working on mobilization platform and mission specific requirements.

TFL – discussed position specific training and coordinating state vs federal. Con op plan also discussed and being updated. Update training on state training calendar. Statewide hurricane drill 3rd week of May and will occur at region level for funding. CERF-P hosting Operation Integration same week. 2016 have secured \$160,000 in exercise training funds and 2017 secured \$200,000.

Medical – solidifying medical protocol with state medical director

ADSAR – 107 exemption certification from FAA for piloting UAV (other than recreational). All written testing, cost \$150. UAV consortium meeting at FRE 2017

SUSAR report

Annual conference in November, focus on hands on training. Next conference in SLC Nov 2017. Continues to work on national US&R standard and certification process. 81 identified US&R teams nationally.

FEMA report

Collapse technician curriculum completed adding 8 hours of computer based training. The Curriculum is supposed to be available in the fall but not out from TEEEX as of this meeting. Train-the-trainer in progress. New Mexico out as fed team, NJ newest fed team.

New business

Request to insure information flow from Business meeting and not work group.

No change at federal level NFPA 1670/1006, at state level, no requirement for updating or recertifying US&R technical rescue training. AHJ has authority to require additional recert training or decertifying members. The FASAR Training committee (2003) prepared task books for after certification training to sign off specific skills that need to be practiced. The AHJ/Program Manager has ability to decertify members of TF. Will have a link to task books for all members on FASAR webpage.

Cache list approval process, FASAR utilizing national standard but information not known at state level. The ANSI standard approved in July 2016. The current FASAR cache list is the 2011 FEMA/US&R cache list. The FEMA/US&R cache list is under approval for 2016. Working off 2011 list put on hold until ANSI standard approved. ANSI list is now approved and agreed to in July 2016. ANSI list is capability based vs tool based. Updated cache list needs to go to representatives of each team.
