Legislative update – Chappell – FFCA Board requesting more information to open the rule making. Looking for support from FASAR. Need to open the Rule to change the following: want to revise the task books that are imbedded in the rule, remove the requirement to use syllabus, revise instructor procedures for tracking in FCDICE.

SFM update – Chappell - Hurrex – each TF to submit 5 scenarios for expected hurricane response specific to their jurisdiction and send to Chief Tucker or Scott Chappell by end of February 2019. Imbed PIO's in the teams/ESF 4/9 capturing images (need to visually document what is happening at the scene). Hurrex need participants at the Hurrex venues. Make training needs known to Fire College. Specialist training schedule and training plan being developed annually.
