- 3) Pay (Portal to Portal)

  - b) FEMA only reimburses up to 16 hours in a 24hr period (work rest cycle)

#### 4) NMAS

- a) Understand the limitation of not being able to deploy both an Engine and the TRT, however we don't want to show any resource as being unavailable or OOS unless or until one or the other has been actually requested. This leaves our options open.
- b) If there is a request for any resource that is listed as available in NMAS and the agency is unable to deploy it for any reason at the time requested, they simply can respond as unable to fill.
- c) As we prepare for any noticed event or incident we will always want to make sure our specialty team status is correct in NMAS, and if for any current reasons that resource is not available, and the status is not correctly shown, then we would want the agency to update that status in NMAS.

  - b) Can send Mission request back to state with an edit (deploying with own mechanic, Type-1 and additional manpower)

- 8) Mission Descriptions
  - a) Statement of what to be expected on deployment (to help with equipment deployment)
    - i) Search
    - ii) Clearing
    - iii) Light Breaching
  - b) State- TRT Functions: Independent Wide Area Search, Backfill FD as TRT Asset, Force Multiplier with TF
