## **Current Situation:**

- State is working on forecasting and planning for increase of Easter travel traffic specific to interstate screen points.
- Surgeon General and Governor conducted a faith-based conference call today to discuss mass gathering. No further information available currently.
- 12-13% of Florida testing is resulting in positive results, with 18% in Miami-Dade and Palm **Beach Counties**
- There is **NO** PPE available. State is continuing research and evaluation of processes to reuse or extend the usability of PPE
- For "Reusable" PPE mission requests, indicate the number of active responders who will be directly issued the equipment. Unrealistic orders will potentially cause a delay to fulfill the request, as additional evaluation will be needed. 1:1 orders are highly recommended currently.
- On-going: Continued monitoring of cruise ships off Florida's coasts.
- On-going: ESF-8 working with ACE on statewide surge plan and establishment of field hospital in Miami-Dade and Broward Counties.
- On-going: Waiting on guidance from Surgeon General on first responder passive exposure
- On-going: Wildfire contingency plan still being developed
- Currently 45 active wildfires.
- 9,585 COVID-19 cases; 163 deaths; 91,000 tested in Florida
- Current number of SEOC Missions: 10.721

## Important takeaways for this document:

- ➤ When ordering reusable PPE, use 1:1 ratio of PPE to personnel.
- > State is researching processes to reuse PPE
- Cases will continue to increase
