Current Situation:

- FLNG working on final draft of County modeling
- Implementation of food distribution plan awaiting final approval
- Infection control team to respond to identified nursing homes
 - 9 FL nursing homes have >5 COVID Patients
 - 40-50 FL nursing homes have 1 4 COVID Patients
- Governor and USCG Admiral to have conversation related to cruise ships off Florida coast and need for plan in dealing with COVID.
 - Estimated there are 35/36k cruise ship crewmembers off the coast of Florida
 - Evaluation of CDC guidance issues late yesterday for cruise ships
- Based on implementation of mitigation strategies on or around March 19th and estimation of a 10-day cycle for COVID symptom, look to begin seeing positive outcomes from these mitigation strategies.
- Non-congregate housing App being created. Data management will be managed by County EM
- *On-going:* Working to determine effect of COVID-19 on the Fire Service personnel and departments.
- On-going: Very limited PPE available.
- On-going: Continued monitoring of cruise ships off Florida's coasts.
- *On-going:* ESF-8 working with USACE on statewide surge plan and establishment of field hospital in Miami-Dade and Broward Counties.
- *On-going:* Waiting on guidance from Surgeon General on first responder passive exposure
- On-going: Wildfire contingency plan still being developed
- Currently 65 active wildfires
- 12,151 COVID-19 cases; 218 deaths; 114,580 tested
- Total SEOC Missions: 11,504
- FL Professional Firefighter COVID-19 cases: 44*


