




## New Resident Cases per Day

### Governor's Plan for Reopening

#### Phase 1

- Schools continue distance learning
- Visits to senior living facilities are prohibited
- Elective surgeries can resume
- Restaurants may offer outdoor seating with 6 ft distance and 25% indoor capacity
- No change for bars, gym, and personal services such as hairdressers
- Vulnerable individuals should avoid close contact with people outside the home.
- All individuals, when in public, should maximize physical distance from others.
- Avoid socializing in groups of more than 10 people in circumstances that do not readily allow for physical distancing
- Face masks are recommended for all those face-to-face interactions where you can't social distance
