SEOC at Level 1 07:00-19:00

From Command meeting 08:30 and SEOC briefing

- 472 COVID-19 cases in Florida
- 10 death, one Broward and One Miami overnight
- 36 Florida counties with reported cases
- Global 210,000 4% mortality rate
- 14% up tick in cases in Europe overnight
- US cases 10,442
- 150 deaths
- All 50 states have cases
- Despite messaging and guidance mass gatherings of greater than 10 are still occurring
- Continue to see cases in nursing homes and adult living facilities
- ESF 16 Law Enforcement to build contingency plan to place officers at the door over of every nursing home and Adult Living Facility to prevent visitation
- Gathering formal inventory by County Health Departments supplies
- Obtaining 3,000 masks from closed schools
- Very large shipment of N95 masks anticipated to arrive on March 23rd.
- Of the 4 mass collection sites at this time:
 - Broward CB Smith Park today,
 - Jacksonville to open tomorrow,
 - Miami Hardrock Stadium on the 23rd
 - Orlando between the 23rd to 25th
- Local fire based Hazardous Material technicians are assisting with personal protection equipment and safety.

Standard Operation Procedures (SOP)
Screening Guidance for FDEM and the SEOC
Florida Division of Emergency Management

Objective: In an effort to minimize any impact to the State Emergency Operations Center (SEOC) during response to the current Covid-19 Health Emergency, the following screening questions and procedures will be put into effect for all visitors to the building:

- Check all employees/visitors for wrist bands date stamped for current-day date.
- If employee/visitor already has a wrist band with current-day date stamp, let them through.
- If visitor does not have a wrist band with current-day date stamp, screening officer will ask the following questions:
 1. Have returned from international travel or been on a cruise within the last 14 days?
 2. Have you been in contact with anyone who has returned from international travel or been on a cruise within the last 14 days?
 3. Have you had contact with someone who has OR is under investigation for COVID-19
 4. Have you been in any gathering of 250 people or more (including airports) in the last 14 days?
 5. Have you traveled to any of the following states in the last 14 days? California? Washington? New York?
 6. Have you experienced signs or symptoms of a respiratory infection such as: Fever? Cough? Shortness of Breath?
 - If the employee/visitor answers “**No**” to **ALL** screening questions:
 - Screening officer will date stamp a wrist band hand the wrist band to the visitor for visitor to place on either wrist (screening officer may help place wrist band for visitor if asked) and will let the visitor through.
 - If the employee/visitor answers “**Yes**” to **ANY** of the screening questions:
 - Employee/visitor will be turned away from entering the SEOC.
 - Alert FDEM SEOC Operations Chief Desk at 850-815-4806 of the employee/visitor being turned away.
 - Turned away employee/visitor will be evaluated on a case-by-case basis by FDEM
- All screening questions will be conducted at the front entrance to the SEOC.
- All employees/visitor attempting to enter the SEOC from the back entrance (The “Breezeway” entrance between the SEOC and Sadowski buildings) without a current-day date stamped wrist band will be directed to the Front entrance to answer the screening questions.
